The application should be send in a sealed cover through Registered-Post or by Speed-Post for scrutiny and consideration by the Selection Committee. Applicants shall superscribe on the envelope: “Application for selection of Member of CWC or Social Worker Member of JJB”. The applicant should use only one application form, even if he/she chooses to apply for more than one position in a CWC or JJB. The candidates should apply from one district only. Applications sent by e-mail, incomplete applications, applications without signatures and the applications received after due date will not be entertained.

Applicants are requested to note that these appointments are purely tenure based appointments to deal with the cases of the 'Children in need of Care & Protection' and 'Children in Conflict with Law'. The selected candidate will be paid sitting allowance / honorarium as may be fixed by the State Government. The term period of the selected candidates will be coterminous with the existing Committees & Boards, which are already constituted by the Govt. vide G.O.Ms.No.4&5, Dept. for WCDA&SC(Prog.1), A.P, Dt:29.01.2018 and are valid upto 28.01.2021.

Only those shortlisted applications, which fulfill the basic eligibility criteria and required qualifications, will be considered to place before the Selection Committee. The shortlisted candidates will have to attend a personal interaction/interview with the Selection Committee for final selection at the above mentioned address or at a venue which may be communicated later.
